Concordia Cemetery, one of the oldest cemeteries in Bolivar County, is located about two miles north of the Town of Gunnison, Mississippi in Township 24 N, Range 7 W, adjoining the Levee. Old Concordia Cemetery is listed in the American Guide, a Source Book and Complete Travel Guide, edited by Henry G. Alsberg and published by Hastings House, N. Y. , and in a book known as a Bible of Old Cemeteries, author and publisher unknown.

The Cemetery contains the graves of many of the pioneer citizens of the northern part of Bolivar County; many among those buried there were the early leaders of the County. The oldest date of burial was John M. Fleming on August 9, 1841; the oldest date of birth was James Irvin on Nov. 7, 1788.

Today, as shown in the enclosed photographs taken on July 17, 1976, Concordia Cemetery is covered by a dense undergrowth of vines, weeds and grass. An effort was made to form a Cemetery Association in the spring of 1962, and the Cemetery was cleaned and a memorial service held there. A historical marker was later placed on State Highway One denoting the historical significance of Concordia.

It is the intention of the Bolivar County Historical Society, as is evidenced by a resolution so stating at its July 27, 1976 membership meeting in Rosedale, Mississippi, to use all means available to reclaim this historic landmark to a state of restoration and preservation.

Below are listed a few of the individuals listed among the 120 tombstones in evidence at Concordia:

\* William Carrol Boyd (Mason) Feb. 14, 1832 Dec. 27, 1916

member of Board of Supervisors 1891; Miss. Levee Commissioner

\* Nelson Blanchard (Mason) Jan. 9, 1806 Mar. 28, 1870

In 1848, he helped build the first Methodist Church

in Concordia.

\* Martin Donelson June 26, 1847 Jan. 22, 1889 His Father was Andrew Jackson Donelson, who owned a large plantation SW of the present Town of Duncan, Mississippi until his death in 1871. Martin Donelson was born at the American Embassy in Berlin, where his Father was the Ambassador to Prussia.

\* Dr. O. L. Deen (Mason) Dec. 24, 1819 Aug. 18, 1858 Early settler on Concordia Island, and helped build

the first Methodist Church at Concordia. \* Aaron F. Goza July 6, 1863 Jan. 29, 1918 Member of an early and prominent family.

\* Wm. Y. Glenn died Nov. 9, 1872, aged 62 yrs, 1 mo, 15 da. The Glenn Family, having come from Kentucky, were very early settlers, and were said to be among the first public school trustees in the County.

\* Isaac Hudson died Feb. 25, 1879, aged 69 yrs, 10 mo., 21 da.

Member of 2nd Board of Police 1837, Sheriff 1844, Representative in the Mississippi Legislature from 1856-8, Levee Commissioner, and School Commissioner.

\* John B. Pease M. D. July 19, 1839 Dec. 6, 1917 Early area physician, leader, among first elected

aldermen of Gunnison.

\* Dr. John B. Pease Jr. (Mason) Mar. 25, 1867 Mar. 21, 1912

Early area leader, doctor, and historian.

\* B. B. Wilson Oct. 1, 1820 June 3, 1875
Owned plantation west of the present Town of Duncan,
Mississippi; prominent pioneer settler of the area;
One daughter married the first Mayor of the Town of
Duncan, Mississippi and another daughter married
Judge J. P. Young, prominent Jurist and Historian
of Memphis, Tennessee.


