THE ESCAPE OF WESTBROOK.

Thos B. Westbrook, who was confined for the murder of Solomon B Isaacs, Esq. (the attorney for this district) made his escape on the evening of the 27th through the assistance of some of the guard who were appointed to watch him. The circumstances as we have heard them, are to put the most charitable construction, appears mysterious.

It seems that the jailor (who was absent) left the keys with a man by the name of Beaty, about 20 years of age; this fellow has also made his disappearance, no doubt in company with Westbrook. The ballance of the guard state that they knew nothing of his escape (which happened a little after supper) until next morning. Whether this is a feasible story or not is left to the public to judge.

The citizens held a meeting on the subject but took no effective measures to arrest him further than to offer a reward, censure the jailor, and exculpate the Sheriff.

In giving our opinion as a journalist, we must say it is passingly strange, that a man arrested and confined under such aggravating circumstances, and who had made his escape once, should have been suffered to escape. To say the least, it was certainly negligence in the Jailor to have left the custody of the jail in such irresponsible hands, without apprising the Sheriff of the county of his so doing.

It also strikes us, that if the Sheriff instead of offering a reward, or becoming responsible for \$500 towards having him arrested should have summoned men to have started in pursuit immediately, ten chances to one he would have been overtaken. The Sheriff knowing the uncertainty of the Jail it is very clear he should have furnished the Jailor with a guard instead of leaving it to him to pick up his guard from among persons he knew nothing about. Under such an arrangement, with the assistance of the jailors family, who reside in the jail, we do not see what is to prevent a pefect security of the prisoners, if there is any thing in the character of men.
