FARM DEBT ADJUSTMENT MEETING

Problems confronting Tishomingo County farmers and their creditors will be brought before the Tishomingo County Farm Debt Adjustment Committee at the monthly meeting which will be held Friday, October 17 at 9:00 o'clock in the office of Hugh T. Ferrell, County FSA Supervisor.

Through friendly discussions between the farmer and his creditors, an attempt will be made to adjust the debts within the farmer's ability to pay. Under this program, the farmer may avoid foreclosure, and the creditor may collect substantial payments on what otherwise might be a frozen debt, Mr. Ferrell said.

Improvement of tenure thru long-term leases also will be discussed at the meeting. Members of the local Farm Debt Adjustment Committee: Mack G. Pitts of Iuka; Zeb B. Akers of Route 2, Iuka; and Charlie Milford of Iuka.
