Jan. 6: Jack called said Miss Oglesby had agreed to wait on Ma for \$10 a month, to be paid quarterly.

Jan. 11: Pros. Whitney was trying to get a subscription paper signed for Mr. Hall preaching. Pros. had his name for \$50 & Mr. Darden put down \$80. The other members had not subscribed. Will Marschalk has given up the Fayette Chronicle to Mr. Paddock as editor and Cully as printer. He sold his furniture off at auction Sat. Merriman was auctioneer. Mr. Hammit has moved to Oakland College to keep the Stewarts house. Ely Jones has rented his place. There was no school. Jesse went by Tom Darden's; Merrick Whitney came home with him, stayed all night.

Jan. 12: Henry Darden went home this evening. He has been to his Aunt Fanny Millsaps.

Jan. 13: Mrs. Newcomb, a relation of Mrs. Judge Whitney, died Christmas night. She had consumption; they lived on the R. Road below Brookhaven. Ann Eliza Clark, Gen. Clark's youngest daughter is with Mrs. Hicks. Mr. Darden was put on the jury as soon as he got to Fayette. The case was the heirs of Aunt Drusilla Chambliss against Wes Whitney. Whitney bought the land at Sheriff's sale. The heirs came & took possession after Whitney had put a man to live there. The jury decided that Whitney had the right of possession.

Jan. 15: Rev. Mr. Burgess came in the rain after 4 oc. He says Mr. McCaleb can't hire hands yet. Mr. Burgess' son was married on the 7th to Miss Gibson, granddaughter of Mrs. Rohelia. Mr. Chamberlain has moved from Pine Ridge. Miss Gusta Ellis was married to Mr. Love, son of Dr. Love. He lives in Enterprise, Miss. They were married at Mr. Anon Killingsworth's.

Jan. 16: Got a letter from Mary Scott, Tom had gone to Robert Scott's in Madison Parish. He would go to Alexandria, La., if he was not too late. The Board of Police have the liberty of educating two boys from each Parish at the State Military School and they have given Tom a chance to go. - Jan. 29: Austin & Clara Smith passed late this evening going to Mr. Montgomery's. Clara & Austin, Tom & Jennie Percy have been on a visit to their Sister Ellen Goode to Thibadeaux.

- Feb. 6: Brother Sam, Buckner & Jack came here today to arrange about Ma being provided for. They are going to buy cooking utensils & provisions. Miss Oglesby will do her cooking for her. It looks hard to think of Ma living & suffering as she does. Brother George went home with Jack. Mr. Darden went with them. Brother Sam & Buck went home.
- Feb. 7: Brother George called on his way home. He says Wes Whitney, his wife & Penn, Merrick & Maggie are going to N. Orleans, also Chambliss Calhoun & wife.
- Feb. 8: Jesse came home wet from school, had a swim at Tom Darden's creek. Capt. Coffey is worse, his sons came from Oxford College to see him.
- Feb. 10: Mr. Darden went with me on horseback to Mr. Montgomery's to see Clara & Austin Smith. Mr. & Mrs. Montgomery have gone to New Orleans will go to Thibadeaux to visit Ellen & Mr. Goode. They left Robert with Clara. Eva & Annie take care of him at night. Jeff Montgomery's widow died Christmas week with pneumonia, only sick few days. Mr. Montgomery, is going to take the little

children, a boy 9 and a girl in her seventh year. Poor children, how desolate to be left an orphan.

Feb. 11: Lena Stuart went to Bolivar County with Toody Clark.
Dr. Wade & Martha were in Fayette yesterday. They sent a ticket
to Capt. Coffey's funeral. Was to be buried in Fayette at 4 oc.,
too late for us to go when ticket came.

Mar. 11: Mr. Darden got home from Dr. Wade's near 1 oc., all well. Dr. Wade has lost three patients lately, all freedmen. Miss Agnes Wade has hired to Mrs. Mabel Wade to do any kind of work.

Mar. 12: Judge Ellis has been appointed in Judge Shackleford's place. He is removed because he can't take the iron clad oath that Congress requires. Cate, Jack & Henry went to the pond to fish. Hiss Cockeral, Mollie Bullen & Lulie Stewart were with them.

Mar. 16: Eddy & Stowers Hicks came after butter & eggs.

Mar. 18: Dr. Wade is troubled about his place. It will be sold under Deed of Trust and he is afraid it will be bid in by some one and he will lose his home.

Mar. 20: Mr. Conner from Kingston came with a letter from Dr. Bass written Tues. 16th. He said Tommie Scott was taken with mumps, then diptheria, rheumatism & erysipelas of the face. Apr. 5: Mrs. Fox moved her plane to Fayette today. Jesse came home this evening; he & Merrick came back to Tom Darden's last night. Joe Whitney has another boy.

I took the red ribbon for butter. Mr. McCorkle took the blue ribbon on fine stallion, he was beautiful. There was no fine saddle horses.

May 23: Jesse did not come home tonight. Stayed with Eddie Hicks.

May 26: Mr. Darden went to see Ma. She is sleeping nearly all the time.

May 28: Mr. Darden went to see his Ma. She is worse, has fever.

May 29: Dr. Tate & Olivia went to see Ma. She still has fever, is wasting away.

May 30: Mr. Darden went with me to see Ma; she still has fever, very restless last night; had not sit up any today. We came home to dinner, went back tonight. I stayed, Mr. Darden came home.

May 31: Had hard rain at 2 oc. this morning. While I was writing this, Mr. Will came running said Ma was dead. Mr. Darden & I left at 6 oc. I could see that Wa was failing; she drank a cup of tea just before I left. She was sensible to the last. Her last words were: "Jesus is waiting in Heaven". I went and helped Cate shroud her. We put a fine black silk dress under sleeves & collar; bought cap trimmed with white. She was so reduced, had bed sore. Had turned black. She died very easy. She has been sick over nine months; would have been 83 the 20th Aug. Mr. Darden had gone for Elic to send for his sister Mary Scott. She was dead before Elic started. Mr. Hicks sold the land as he was Trustee. Mr. Darden bit it in for \$1121 & gave his note payable first Jan. at 8 per cent interest till paid. Mr. Read & Mr. Farley & Hicks were there. Ira Robertson had preaching at Springhill to the freedmen today.
- June 13: Jesse & Henry came back this eve., had a good rain at Mr. Bullen's. Miss Clara Marshall went home with them last night from Mr. Osburn Scott's, Lizzie & Tom Drake were there. Jesse says their babe has a large nose like her Pa. Irene sent me her photograph taken with little Laura in her lap.
- June 17: Mr. Darden went to Fayette, paid Jeff Key for Ma's coffin. The coffin was \$110 with the use of the hearse. The brothers will pay for it.
- June 20: We went to the Meth. Church. Julia Wade was there, had her baby. Cate stayed to help her sister, Mrs. Stewart sew. Lula & Fanny are going to visit their father's relations in the West. Will be gone two months.
- June 23: Eddie Hicks & Dudley Stewart went to Jack's tonight.
- June 24: Mr. Darden went to help decide Mrs. Adaline Dangerfield place. The Commissioners divided it in lots 2, 9 & 14 acres. The Campbell children got the 2 acre lot between Judge Ellis & the house. Mrs. Wigginton drew the improvements. The other was for Isaac Burch. Brown Stewart called on his way to Natchez; said Lou Darden & Lena Stuart went to the Mason's celebration at the Union Church today.
- July 1: Mr. Darden went to Fayette, paid Mr. Paddock \$15 for printing obituary of his mother & funeral tickets.

July 7: They sent us a ticket to Coz Margaret Darden's funeral. She died suddenly last night at 12 oc., sitting in rocking chair. She has been sick eight years with paralysis. She was staying at Joe Whitney's while Tom was at Jackson as juror of United States Court.

July 8: Mr. Darden & George went in to Fayette to come with the procession. When he got to old Harry's house, the little negroes ran behind George's horse, made him run, he threw George. Mr. Darden's horse ran then; his stirrups broke; threw him on the rocks on his left side. The horses ran nearly to Fayette. He went to Dr. Richardson's; he told him his fourth rib was broken, his left shoulder is very badly bruised, his leg & knee badly hurt; his hands bruised bad. I was at Cousin Margaret's. July 22: Jesse went to Mr. Fay's examination at the Academy. Dr. Wade & Martha came with the children at 1 oc. Dr. Wade says Mr. Darden's collar bone is broken.

July 23: Dr. & Martha started at daylight. Julia & Mr. Wade came this evening. Jesse went home with Ed Hicks. Mr. Bridewell came from Port Gibson this evening.

July 27: Jesse came home yesterday. Came from Coz Sarah Stowers; was at Mr. Montgomery's & brother Buck's while he was gone.

- July 28: Jesse went to Dr. Tate's. Olivia had toothache, took morphine & she was vomiting.
- July 30: Mr. Hicks & Paddock came to see Mr. Darden on business.
- Aug. 1: Irene's fever cooled a short time. Dr. Richardson came to see Irene, he gave her blue mass with soda & something to quiet her nerves. He said to give her quinine till the fever got very hot, then quit. Mr. Fay, the President of the Fayette Academy, came with him.

Mr. Hall preached his last sermon. He will leave Tuesday for Arkansas to get a home then move his family.
- Sept. 15: Irene received a letter from Ellen Goode with her babe's photograph. It is a fine, large babe.
- Sept. 18: Laura left half past 4 oc to meet the stage at Middleton's gate. When she got there the stage driver would not take her trunk.
- Sept. 19. Laura writes she stayed at Saragossa last night with Clara Smith. She would get a boat today.
- Sept. 24: Mr. Darden went to Fayette, got a letter from Jesse; the trip cost \$25. He was not able to enter the freshman class; went into the preparatory department.
- Sept. 25: Jack packed his bale of cotton. Henry started to Natchez with it this evening to take it to St. Louis fair. Jack borrowed \$ from Mr. Darden, for Henry to go to St. Louis.
- Sept. 26: Mr. Darden went to the Presbyterian Church. Rev. Mr. Hall preached. He is willing to take charge of two Churches for \$1500 a year.
- Sept. 27: Mr. Darden went to Fayette. Court began today. Tom Drake of Rodney & Nelson Newman had a difficulty in Fayette today. They both fired their pistols in the crowd; shot Dr. Noland in the arm, and young Mr. Green in the back. Nelson Newman was badly shot in his side.

- Sept. 29: Rev. Mr. Cleland came this evening after 3 oc., he says Mr. Carradine's dwelling house was burned on Monday at 11 oc. Caught from the chimmey. - Oct. 10: We spent the day at the Hotel till nearly sundown, went to the wharf boat stayed all night. Very poor accommodations, no fire. Little Laura very cross. We suffered with cold; the staterooms sash broken out; drinking & carousing on the boat.
- Oct. 11: The "Wild Wagoner" got to Natchez at 7 oc. Mr. West came on the wharf boat we all went on the Wagoner and eat breakfast. Laura came up from Clinton with Mr. West. It made me sad to part with Irene. We may never meet again. Her health is bad, having fever every few weeks. The boat left at 8 oc., they will stay in Bayou Sara tonight. We left Natchez at 2 oc., got home half past 7 oc. We met Sarah Darden & Lou at Washington going to Natchez.
- Oct. 13: Rev. Mr. Weeks called on his way to Presbytery. Mrs. Tom Hall was brought home a corpse last week. Mr. Darden went to Fayette, got a letter from Will Collier, relative to the land that belonged to Buckner. George seems to be better pleased with school.
- Oct. 15: Laura sent letter to the office for Jennie McGehee & Irene.
- Oct. 17: Tom Darden got home from St. Louis fair yesterday. He left Henry Darden at Jimmie Darden's in Bolivar. Henry did not get the premium on his cotton.
- Oct. 18: Miss Mary McCallum was to be married this evening to her cousin from North Carolina of the same name.
- Oct. 19: Mr. Pros Whitney told Mr. Darden that Prosper K. Montgomery told him he was not going to give anything for the support of the preacher; he did not expect to attend Church. Could not fellowship with some of the members. How distressing to see our Church going down.

- Nov. 12: Began to rain at 7 oc. Laura, Florence Calhoun, Mr. Bridewell & Mr. Darden went in after dinner. The fair did not topen till 12 oc. There were more horses shown, horses ran around the half mile circle.
- Nov. 13: We all went to the fair. There was 16 knights rode in the tournament. Tom Drake & Chambliss Calhoun were the successful knights. Miss Mattie Hunt was chosen queen of Love & Beauty. - Nov. 27: I prepared dinner for Mrs. Paddock & Miss Coulson. They did not come. Mr. Darden received a letter from Jesse; he is anxious to come home Christmas. His report came Friday. His conduct is no 1. Distinguished in Greek no 2; excellent in Latin & Mathematics no 3. Good, very good report.
- Nov. 28: Laura wrote they were well. Dick Scott was there, had just been to a party at Brother George's given to Miss Mattie Valentine. (Mrs. Millsaps)
- Nov. 30: Mr. Darden went to Fayette. Voted for Dent for Gov. and Jefford's for Lieut. Gov. The freedmen voted for Alcorn for Gov., bitter radical. Mrs. Capt. Harper has a boy born Sun.

- Dec. 2: Mr. Tucker has bought a part of the Sam Hill place from Henry McClure, his son-in-law.
- Dec. 3: Lum took the horses to Dr. Wade's; Miss Lottie came home with Laura; Olivia & Johnnie came at 4 oc., this eve. Dr. Tate's health is not good. Amelia Bass has another son. It was born the 8th Nov. I received a letter from Irene; her health was better. She expected to go to Terrabone the 1st Dec. Visit Mr. West's mother & relations.
- Dec. 4: Olivia is 32 years old today.
- Dec. 6: Ambrose Geoghegan came to get Mr. Darden to wait till March for the borrowed money.
