Wanted George to go back in Holmes History that he studied 2 years ago with Mr. Fay. Mr. Roberts that lives at Mr. Jones called to know where the school house is to be put. He says Mt. Carmel Church was burned down Sat. night; the work of an incendiary.
- Oct. 18: Nr. Darden went to dinner at Mother Robertson's with her son, Ira. Ira preached today.
- Oct. 21: Mr. Darden received a letter from Mary Scott, are well. Tom returned home last Sept. went by N. Orleans, Galveston & Houston. Mr. Majors living on the Howell Hinds place was killed yesterday evening by Jeff Bargy. He rented land from Majors; they had a difficulty & Bargy ordered Majors off the land he shot Majors with buckshot. Masons & Grangers went to bury Mr. Majors this evening. Mr. Gerald Brandon's death is announced in the Courier; he died Sun, Oct. 18th. Old Mr. McCullum died Sun. He has lived at Salsertown for over 30 years.
- Oct. 24: Mr. Darden & Jesse went to Fayette. They were trying Jeff Bargy. Mr. Darden thinks it was premeditated murder from the testimony. I received a letter from Irene. Mr. West cannot go to Texas as he expected; there is a mortgage on his mother's place, that will have to be raised before he can leave for \$2,000.
- Oct. 25: Mary Bondurant had twin boys, named Montgomery Peyton after Grandparents on both sides. They are three weeks old.
- Oct. 27: Mr. Darden met Capt. John Cameron moving with his family to Texas.
- Oct. 28: Dick McCoy died this morn. at 3 oc. Mr. Darden went there after dinner. Miss Mat Skinner & Miss Ogden were there. Dr. McArn died last night at 7 oc.
- Oct. 29: Mr. Darden went to see Dick McCoy buried at Greenwood Church. Joe Grover has got out letters of Administration on Mr. McCollum's estate. He claims to be a relation. Mr. Mc. told several he did not have a relation that he knew of.
- Nov. 1: Dr. Richardson over took Mr. Darden; he says Mary Lou Darden's babe was a girl, two hours old. M. R. says Cousin Sarah Stowers has comsumption. He was going to see her this morning. She is at Mr. Hicks.
- Nov. 7: George & Johnnie went to Uncle Jack's; Kate told him Olive Whittington had a boy, born yesterday. Mrs. Willie Stampley, a girl born this week. Mr. Darden received notice today that Olivia's tombstone had been shipped from St. Louis to Natchez.
- Nov. 9: Billy McCaleb called to get water; his Pa & Ma came up to the fair.

- Nov. 10: Mr. Darden drove Sue's mule in the buggy, took Johnnie with him to the fair. The Grangers were there in uniform.
- Nov. 11: We all went to the fair; fine display of jellies, preserves, honey pickles, butter, etc. Cunningham Whitney had pound fruit, jelly sponge & tea cakes. There was a variety of needlework. Old Mrs. David Hunt was buried Monday (9th). Jimmie Brandon's little boy was buried on Mon. too. He was a great Grandson of Mrs. Hunt's.
- Nov. 13: Mr. Darden, Jesse, George & Johnnie all went to the fair. The Earthquakes were there in uniform with false faces & dressed in all sorts of ways. Henry Garrett spoke. Had a tournament. Effic Torrey, Clara Tompson & Carrie Key were crowned a queen of love & beauty. Jesse went to a party at Dunc. Chamberlain's tonight.
- Nov. 15: Mr. Darden, George & Johnnie went to S.S. there was no school. They went to hear a Catholic priest preach in the Court House.
- Nov. 17: Mr. Darden started to Fayette, got near Pros Whitney's gate, it began to rain, he turned, very hard rain on him before he got to Robertson school house; he waited there, then came home in the rain.
- Nov. 18: Mrs. Pros Whitney has a boy; been looking two months.
- Nov. 19: Jack Darden went to borrow our carriage horses to go after Lou Darden & her Ma. They are at Mr. Skinner's. Jimmie Darden came up yesterday, rode Skinnder's mare.
- Nov. 20: Mr. Darden went to Fayette. Came by Pros Whitney's, bought the sorrel pony & gave \$100 for him. Mr. Whitney still owes \$19 on the note.
- Nov. 21: Hugh & Lena Montgomery got here at 1 oc. We were just done dinner.
- Nov. 22: Jesse went to his Uncle Jack's. Jimmie Darden came home with him, tonight. Lou & her Ma are at Jack's. Lou is going to spend the winter with her sister Annette McMillan. Mr. Martin that married Mollie Davenport started to Texas last Thurs.
- Nov. 24: Jesse rode Sue's mule this morning to Mr. Hicks'. He will go with the boys to a party at Mr. Bachelor's near the Bell Grove.
- Nov. 25: Jesse got home from the party after 1 oc., not many there. Dr. Penn Whitney was taking Miss Mollie Reed to the party & his horse ran away, threw both of them out, broke the buggy all to pieces. The buggy belonged to Mr. Love. Miss Mollie had to walk 2 miles. Chas. Coffey took a horse for her to ride. Her leg was cut badly.
- Nov. 26: Jesse drove Jeff Davis to Natchez in the buggy. Jimmie Darden is going with him.

- Nov. 27: Mr. Darden saw Mr. Jones; he thinks Elic Compton will get the school near here.
- Nov. 29: George & Johnnie walked to Uncle Jack's with Jimmie Darden & Jesse went to Fayette to hear Capt. Harper speak at the Bible Society. Mr. Darden went by to dinner at Put Darden's.
- Dec. 1: Lou & Kate Darden, her two children & Dewitt Dixon came after 11 oc., stayed till late in the evening.
- Dec. 2: Sarah Darden called at the door; she wants to go to Natchez tomorrow, so she can take a boat for home in Bolivar. She said she did not collect the money due her for her furniture; had to sell a cow for \$10 this morning to get money to go home on. She wanted to pay some on the note Mr. Darden holds against them, but could not collect her dues. Amelia Green was married Sun. (29th) to a Dutchman, Mr. Hans; he has worked there this year with Bill Buckels. I received a letter from Jennie Sillers; her Pa was better.
- Dec. 4: Mr. Darden & the boys went to the Grange celebration. Capt. Whitney spoke. Jesse came home & went in our carriage to the party with Lou Darden. There was a dispatch went to the Sheriff of Jefferson says there was a mule taken from a negro in Natchez, who said he took the mule from Mr. Darden's living 10 miles from Fayette. It must be brother Sam's mule.
- Dec. 6: Russ, son of Capt. Sam Montgomery, was shot Thurs. He sit his gun by a tree, the dogs threw it down, the load went in his arm. It is thought he will lose his arm.
- Dec. 7: The negroes are marching on Vicksburg; they were met by the citizens & 20 were killed & more wounded. Jesse went to Fayette, Dr. Shannon telegraphed from Vicksburg that the negroes were burning houses in the country & threatened to kill the women & children. Put Darden got a company, were to start tonight to assist Vicksburg. Tom Darden, Ed & Stowers Hicks, Elic & Dud Scott, Tom Drake, Dick Dobyns, George Torrey & Jesse met near Mr. Torrey's. There was so few they came back.
- Dec. 8: The news is all quiet at Vicksburg. Jesse stayed with Tom Darden tonight.
- Dec. 9: Jesse came home this morning. He is to call on the Miss McCaleb's at Mr. Whitney's with Ed Hicks.
- Dec. 11: Jesse & Ed Hicks got here to dinner at 2 oc. They went to Mr. Whitney's in the carriage & took Miss Sue & Lillie McCaleb to the dancing school at Mr. Tunstill's; got home after 1 oc.
 - Dec. 15: Jesse went to Tom Darden's to call on Miss Sue McCaleb, stayed all night. Miss Lillie went home yesterday, Rivers Harrison went with her. He went back to school at Washington.
 - Dec. 16: They are taking the testimony about Jeff Bargan killing Mr. Majors.

- Dec. 22: Dr. Richardson went to Rodney for his daughter, Eliza; she has been at school in Tenn. Pauline Shackleford & Bettie Harper came home with her.
- Dec. 23: Jack Darden came & borrowed Tom's mule to take Lou Darden to Monticello. Went to Mr. McArn's tonight.
- Dec. 24: Dr. Richardson brought Penn Whitney out, Harry's (negro) leg was too much swollen for them to cut it off. Dr. R. told Harry he would take it off if he said so; but it would only shorten his time here; said he might live 36 hours & he might not live 6. He lived 12 hours died tonight at 10 oc.
- Dec. 25: John Darden came & spent the day & night. Jesse went fox hunting this morning with Tom & Henry Darden.
- Dec. 26: Mr. Darden went to the Grange. Will Davenport spent the day hunting with George & Johnnie today. Horation Fleming woke up Thurs. with headache. Dr. Guice thought he would not live through the day. They think it is meningitis.
- Dec. 27: George went to see Horation Fleming this morning; Horation was better. Dr. Guice thinks he will get well. George went to Mrs. Robertson's & Johnnie pulled his last lower jaw tooth.
- Dec. 28: Jesse started to Mr. Montgomery's, met Johnnie Bondurant at William Fountain's, they came back here. George & Johnnie Tate went & hunted with Johnnie Darden.
- Dec. 29: Mr. Darden went to darling Olivia's place. I sent violets, ivy, Cape Jessamine & weeping willow to set out at the graves of our dear ones.
- Dec. 30: Jesse & Johnnie Bondurant started 15 min. after 3 oc. to a party at Mr. Anon Killingsworth's to be given to Miss Sallie & Jennie K. & Miss Kate Scott.
- Dec. 31: Mr. Massey from Texas has come, report says to marry Miss Ann T. Harper. Jesse & Johnnie B. went home with Ed Hicks.
