TO THE TAX-PAYERS OF TISHOMINGO COUNTY.

I will attend at the following times and places, for the purpose of collecting the State, County, and Special Tax for the fiscal year 1856, also the balance due for the year 1855. All persons that have to pay tax, are hereby requested to meet me promptly at the times and places specified and pay their tax. The law requires me to attend at different points in the County, and it makes it equally the duty of tax-payers to attend at the points indicated, and discharge the obligations imposed on them by law.
