#### SORSBY IS PARDONED FROM PENITENTIARY BY GOV. WHITFIELD

The following was published from Jackson, Miss., under date of December 24, ult:

"Governor Whitfield today pardoned W. A. Sorsby from the state penitentiary. Sorsby was serving a life sentence for the murder of Postoffice Inspector Charles Fitzgerald in 1909 at Clinton, Miss. According to the testimony on the trial, Sorsby shot Fitzgerald in the back as the latter was boarding a train for Jackson, after having exchanged goodbyes with Sorsby. The inspector had checked Sorsby short in his accounts with the postoffice at Clinton, in which he was employed at the time. Attempts to secure his pardon from every governor since Sorsby's conviction have hitherto been refused."

It is stated that the pardon was granted over the protest of Postmaster General New, and the Postoffice Department at Washington has made a determined effort with the advent of each succeeding political regime in Mississippi to keep Sorsby in the penitentiary. Each governor has been urged not to give him a parole or a pardon.

Attached to the pardon were the following reasons given by the governor for its issuance:

"This pardon is granted because when the crime was committed Will Sorsby had hardly reached a man's estate, and consequently did not possess that experience that would cause him to realize the enormity of the crime he was committing; the fear that he and his family would be disgraced because of certain official irregularities also caused him to be in a state of mind which prevented him from realizing that he was committing the crime; and the further fact that he has already served a longer term of service than is usual for life prisoners."
