Know all men by these presents that I Nancy Joslin for and in consideration of the natural love and affection which I have and do bear toward my beloved son, Albert Q. Joslin, have this day given and granted to be delivered at my death and by these presents doth give grant and deliver unto my said son Albert Q. Joslin at my death the following property to wit: the south half of the N. E. quarter of Section sixteen Township three (3) Range ten (10) East in said Tishomingo County with all the appurtanances thereunto belonging to have and to hold the same unto my son Albert Q. Joslin and to his heirs and assigns forever.

In testimony whereof I the said Nancy Joslin have hereunto set my hand and seal this the twenty ninth day of November A.D. 1875.
