Daily Corinthian (Corinth, Miss.), July 25, 1957 Transcribed by Helah Wilson and Janice Switcher.

Services for victims of a head-on automobile collision will be held today. Dead are Olen William Rhodes, of Kossuth and Harley O. Moss of Paden.

Both men were killed instantly when their car crashed together on Highway 45, six miles north of Booneville. The wreck occurred at 4:30 Thursday morning.

Mr. Rhodes was on his way to Mississippi State College to attend a 7:30 class. He would have received the Bachelor of Science Degree in August.

Mr. Moss, an insurance agent was traveling form his home in Booneville to his office in Corinth.

Services for Mr. Rhodes were to be held at 2 p.m. today in the Kossuth Baptist Church with Rev. Cleaton Wilbanks, Rev. W. C. Gann, and Rev. W. T. Bazzell officiating. Burial will be in the Union Cemetery with McPeters Funeral Home in charge of arrangements.

A teacher in the Kossuth School, Mr. Rhodes was a native of Alcorn County. He was a member of the Baptist Church.

He was married to the former Erma Elliott in 1932. He was 46.

He leaves his wife, a son, Max Rhodes of Kossuth; his parents, Mr. and Mrs. W. A. Rhodes, a brother, Elmer Rhodes and a sister, Mrs. Jewell Leatherwood all of Corinth.
