## Supervisor's Proceedings at January 10, 1910 Meeting

....Permission given J.C. Miller et alto build telephone line on luka & Fulton road; change the Church public road granted T.L. Browning; public road allowed W.R. PHARR by old Bethel Church, same to W.R. Sample by Bethel Church; Carter Shook constable state eases \$32.50; change in public road allowed J.P. STAMPHILL, C.A. PILLS and RB. TWITTY.

Whereas it appears to the board that there is considerable complaint begin made by the citizens of Tishomingo County about the condition of gates across the public roads, and whereas the U.S. Government has declared that RFD service will not be maintained unless all gates across said routes are made automatic, it is therefore ordered by the Board that where any gates appear hereafter across public roads which are RFD and all gates that are now being kept across public roads which are RFD must be supplied with automatic gates and unless said order be complied with by the 1st of May, 1910, all gates must be removed from across public roads.

R.B. Twitty authorized to build two automatic gates on Russellville road; Marvin Mink appointed overseer link 83; John PERRY link 10 in place of Rufus Clay who moved away; Board rescinded its action regarding the petition of C.A. PITTS for public road. The following overseers were appointed: Albert Brewer link 127; W. CALLICUTT link 105; G.M. Sanders Link 3; J.D. Paden link 137; 1. A. Rinks link 68; Steve McDOUGAL link 136.
